**Summary:**

This report is presented to Council to provide information relating to the current status of Walgett Shire Council Family Day Care Scheme.

**Comments (including issues and background):**

Walgett Shire Council Family Day Care is currently experiencing difficulties with attracting carers to the Scheme. At present Council has only one (1) carer located in Collarenebri and one (1) potential carer due to join the Scheme in January 2008 at Lightning Ridge. Family Day Care Co-ordination staff are continually advertising and promoting the service in the whole Shire in order to recruit and retain carers. The funding impacts on the ability to promote and market the service must be taken into consideration.

The on going costs associated with interviews and Carer Induction are also difficult and are a cost burden on the Scheme when distances to be travelled are vast.

Family Day Care is an invaluable service for the Shire and the opening of Walgett Pre School and Long Day Care Centre has had an impact on the situation in Walgett. As this centre reaches capacity especially for ages 0 – 2, it is expected that the need for Family Day Care will increase.

Council recently requested approval from the Minister for Community Services to allow the offices of Walgett Family Day Care to be used as a venue for Family Day Care. This request was declined.

I refer to our meeting of 2 October 2007 and also to your correspondence received by me on 3 September 2007, requesting approval to allow family day care carers to provide care for children at the offices of the Walgett Family Day Care Scheme.

I would like to confirm the advice previously provided to you on this matter by the former Minister of Community Services, the Hon Reba Meagher MP.

The advice noted that a family day care children's service is defined in the *Children and Young Persons (Care and Protection) Act 1998* as a children's service that organises or arranges for the care to be provided at the home of a carer, and that the *Children's Services Regulation 2004* defines a family day carer as a natural person who is directly involved, at his or her home, in educating, supervising or caring for children for family care children's service. Advice was also provided on the NSW Department of Community Services' (DoCS) role of licensing, regulating and monitoring children's services in NSW within the provisions of this legislation.

Hence, as was previously advised, Council's proposal to establish a child care facility at the offices of Walgett Family Day Care Scheme where the care is provided by family day care carers is not permissible under the Act or the Regulation.

I can assure you that children's services legislation in NSW is not intended to constrain the provision of places to meet community need or to inconvenience parents. As you will be aware, the licensing of children's services in NSW is intended to ensure that children's developmental outcomes are enhanced in a safe, well-regulated environment. This is, I am sure, entirely consistent with the aims of Walgett Shire Council and Walgett Family Day Care Scheme.

In regard to the need for additional child care in Walgett, I note that the Commonwealth Government is offering Family Day Care Start Up Payments of around \$1,500. The payment aims to encourage people to consider Family Day Care as a career option and to assist with some of the set-up costs involved in establishing a Family Day Care business. Remote Area Family Day Care Start Up payments of \$5,000 are also available to assist carers living on properties in remote or very remote areas to undertake essential changes to their home or its immediate surrounds in order for them to provide quality child care. I am also advised that DoCS' Western Regional Office has recommended that Council seeks to negotiate the inclusion of Walgett in the service scope of the existing Goonimoo Mobile Children's Service. Included in this recommendation is that the offices of Walgett Family Day Care Scheme be used as a mobile service venue.

The Goonimoo Mobile Children's Service is located at Lot 1 Dundas Street, Walgett and is auspiced by Walgett Aboriginal Medical Service Co-op Ltd. **Summary:**

This report recommends that Council donate an amount equivalent to the Development Application fees under Section 356 of the *Local Government Act* 1993 to assist the Lightning Ridge Central School with the cost of building a covered outdoor learning area.

**Comments (including issues and background):**

On 14 November 2007 Council received a written request from the Lightning Ridge Central School Parents Teachers Citizens Association asking for financial assistance towards a covered outdoor learning area. The total quote for the project is \$102,256. To date Lightning Ridge Central School have received grants and contributions totalling \$97,292.00.

Community organisations may apply for financial assistance under the Walgett Shire Council's Community Assistance Scheme and under Section 356 of the *Local Government Act* 1993. Applications close on 31 July each year, for consideration by Council in the August Meeting.

Lightning Ridge Central School submitted an application for a different project in July 2007. The application for financial assistance to employ a teacher's aid was unsuccessful. Lightning Ridge Central School did not submit an application for financial assistance towards a covered outdoor learning area.

Whilst this application for financial support was not included in Walgett Shire Council Community Assistance Scheme, it is consistent with provisions of Category C – Community Assistance Schemes.

A Development Application fee of approximately \$560 would be payable on the application.

Covered Outdoor Learning Area (COLA)

Lightning Ridge Central School applied and was granted \$77,292 from the Department of Education, Science & Training through the Investing in our school grant for a Covered Outdoor Learning Area (COLA) over the secondary quadrangle.

The erection of a C.O.L.A. over the secondary quadrangle will aim to provide 100% weather proof protection for students in our hot arid climate and this will provide an outdoor learning area to enhance our exercise programs as well as whole school assemblies or celebrations e.g. N.A.I.D.O.C. Week, Centenary.

The quote entered in the grant application was for a 30m L x 30m W x 7m H COLA at the price of \$102,256.

The PTCA was approached to contribute the short fall of at least \$43,084 when the application was sent. We have \$10,000 currently to contribute to this project and the Lightning Ridge Bowling Club have kindly contributed \$10,000 and we are talking to other prospective beneficiaries to donate funds towards the COLA.

**Summary:**

This report recommends that Council rescind Policy 1D.3 Conditions of Employment, sections 4.Electricity, 9.Telephone Incentive and 10. Telephones in Residences. It is recommended that Council adopt the attached draft Walgett Shire Council Staff Subsidy Policy.

*“That Council reimburse the connection fee and 20% of costs of household electricity to employees who have filled positions which require advertisements in the Sydney Morning Herald or Australian Local Government Job Directory.”*

*The subsidy is to apply to designated positions within Council’s staffing structures from time to time, subject to the incumbent attaining the maximum salary level pertaining to the position as identified by Council’s salary system.”*

**TELEPHONE INCENTIVE**

- (b) Those employees appointed to the positions of General Manager and Chief Executives of Council’s functions be reimbursed 75% of the cost of phone calls, and the Deputy Chief Executive of Technical Services be reimbursed 50% of the cost of telephone calls. Council to pay the cost of rentals and installation of telephones attached to these positions.*
- (a) That Council not reimburse the cost of overseas telephone calls, with the exception of the General Manager and Chief Executives who may be required to make such calls.*

As part of Council's on-going review of policies and procedures a review of subsidies and incentives paid to Council's staff was undertaken. Council's policies relating to staff subsidies and incentives require updating to provide consistency in application and fairness to all eligible staff. Many of the current policies refer to position descriptions that are inconsistent with Council's current staff structure.

Currently 9 staff members receive a 40% electricity subsidy included in their letter offering employment. There is consistency in the offers however fairness would be better served with a policy to be applied consistently to all eligible staff members.

With the increased utilisation of new technologies to enhance Council's performance of tasks, from time to time policies need to be reviewed. Currently all Council staff who need to be contacted after hours have been issued with mobile telephones to improve response time to after hours issues. The use of mobile telephones has removed the need for staff to use their home telephone for Council business. There is no need for home telephone cost subsidies to continue to be included in employment offers or to remain within Council's policies and procedures.

Currently 10 staff members receive telephone subsidies ranging from 25% of local calls to 50% of all calls including all rental and installation costs. As these benefits form part of each employees conditions of employment, the changes relating to subsidies could only be implemented in consultation with each individual employee to form part of their employment conditions. In the event that the employee did not consent to the revised Conditions of Employment, their initial conditions of employment would continue.

The revised policy was presented to the November 2007 Council meeting where it was deferred. This policy will relate to all relevant employees employed after the date of adoption of this revised policy.

**Summary:**

This report provides activities suggested for a week long 'Clean up Australia' project in 2008 as well as future projects that will incorporate the entire community including business houses, schools and the general community in all towns and villages in Walgett Shire.

The focus will be on two major long term projects:

1. Reducing Walgett Shire's ecological footprint and greenhouse gas emissions with a tree planting project.
2. Reducing the number of plastic bags put in landfill by providing every household in Walgett Shire with a reusable shopping bag.

**Comments (including issues and background):**

Clean up Australia Day has moved from a single day of cleaning up a designated area by individual community groups into a week of activities with emphasis on long term initiatives put in place by whole communities.

For the past 3 years the Walgett Shire Community has participated in segments of the Clean up Australia Campaign, but with such an emphasis placed on recycling and reducing green house gas emissions, it is time for Walgett Shire Council to lead the way in changing our future environmental direction.

Initiatives for Australia Day Project:

**Business Clean Up Day – Tuesday 26 February 2008**

- Invite Businesses to implement one environmentally sustainable initiative in workplace
- Promote one initiative for entire Business Community to participate in: E -Waste Recycling, (Invite Yeoman's Recycling to pick up all e-waste from Business Houses).
- Ask businesses to reduce their ecological footprint or greenhouse emissions: 'BUY A TREE.' Council to order and plant.
- Net Waste to Art – Use rubbish collected to enter art competition.
- Invite Country Energy to provide Free Light Bulb and Showerhead exchanges.
- Ask business houses to use less paper by registering their email address on Walgett Shire Council's Community Directory at [www.walgett.nsw.gov.au](http://www.walgett.nsw.gov.au).

**Schools Clean Up Day – Friday 29 February 2008**

- Ask school groups to actually participate in the schools clean up day by cleaning in and around school or designate a specific site.
- Invite school groups to implement a school project: Develop a worm farm or compost.
- Reduce your ecological footprint or greenhouse emissions: 'BUY A TREE.' Council to order and plant.
- Net Waste to Art – Use rubbish collected to enter art competition.
- Invite Country Energy to provide Free Light Bulb and Showerhead exchanges.

**Clean Up Australia Day – Sunday 2 March 2008**

- Clean up local environment, designate a specific site.
- Clean up individual homes and properties
- Organise Council to pick up rubbish
- Kerbside Clean Up – Invite Yeomans' Recycling to pick up large pieces of rubbish.
- Provide FREE Barbeque at designated clean up site.
- Net Waste to Art – Use rubbish collected to enter art competition.
- Invite Country Energy to provide Free Light Bulb and Showerhead exchanges.
- Reduce your ecological footprint or greenhouse emissions: 'BUY A TREE.'

It is recommended for Walgett Shire to have a positive impact on its environment; several initiatives will need to be introduced, the first of which is a tree replacement program; namely "Reduce your ecological footprint; buy a tree" to begin in 2008. This initial project will need financial support from Council while it is envisaged future project costs can be offset with several funding options including Planet Ark, Australia's Open Garden Scheme, Eco Schools, Energy Savings Fund and several other environmental funding programs.

1. 'Reduce your ecological footprint, buy a tree'

In an effort to have Walgett Shire Residents offset the impact of their ecological footprint, Walgett Shire Council will initially purchase 2,000 tree seedlings to be purchased by businesses, schools and individuals, this will however be an ongoing improvement project.

The trees will be planted and maintained by Walgett Shire Council, they will line the entrances of two towns; to be decided at a later date. This will have a great impact on visitor's first impressions to towns.

The type of species to be used will be decided upon after consultation with Council Technical Officers. Maintenance will also be a major factor in the success of this project, the ground will need to be prepared prior to planting and constantly watered to ensure the seedlings are given the prime environment for them to thrive in our current dry conditions.

Council has contacted Narromine Transplants who offer seedlings @ \$550/1000 including GST.

2. Project for 2008/2009 'Say No to Plastic Bags'

An estimated 3.76 billion bags or 20,700 tonnes of plastic are disposed of in landfill sites throughout Australia every year. It is suggested that Council, when considering the 2008/09 budget, allows for the ordering of 10,000 reusable shopping bags to combat this figure and reduce the use of plastic bags in Walgett Shire. Each household in Walgett Shire could be sent one of these bags free of charge with the opportunity to purchase more from Council.

The bag will be emblazoned with the Council's corporate logo and slogan and will be used as a promotional product at trade shows and will also be sent out to new residents in Councils 'New Residents Welcome Kit'. Several quotes have been obtained, the indicative cost for 10,000 bags being in the order of \$15,000 plus freight and GST.

**Summary:**

This report outlines the condition of playground equipment currently located throughout the Walgett Shire. Included in this report is the location of equipment, condition and compliance with Australian Standards, and recommendations.

**Comments (including issues and background):**

The history of playground equipment breaks down into different eras:

1900 – 1950's	The Manufactured Appliance era
1950's – 1960's	The Novelty era
1960's - 1970's	The Log era
1970's – 1980's	The Modular era
1980's – 1990's	The Safety era
2000's	The Millennium era

Apart from the equipment in Gray Park Walgett, which is from the Modular era, all other playground equipment within the Walgett Shire is from the Manufactured Appliance era, 1900's – 1950's.

Playground equipment throughout the Walgett Shire is located at:

- Gray Park, Walgett
- Pearson Park, Walgett
- Apex Park, Walgett
- Collarenebri
- Cumborah
- Carinda
- RG Garvey Memorial Playground, Burren Junction
- Cambray Park, Burren Junction
- Lightning Ridge Visitor Information Centre
- Ginghi Reserve via Carinda

A visual inspection of the playground equipment within the Shire shows that at present there is a lack of compliance with Australian Standards AS4685, Playground Equipment.

Standards are not mandatory; however, compliance represents good practice and may be referred to in court cases.

Some of the safety issues identified include:

- None of the playgrounds visited had any kind of impact absorbing material (soft fall).
- Some of the equipment inspected had been vandalized.
- The majority of the equipment inspected was very old and of steel construction
- The location and proximity to other equipment did not conform to standards.

**Summary:**

This report recommends that Council note and endorse the work performed by Mr Richard Wesley, Walgett Shire Museum Advisor in relation to work performed for Walgett District Historical Society and Lightning Ridge Opal and Fossil Museum.

**Comments (including issues and background):**

Museum Planning Services Australia (MSPA) assists Council with the funding and engagement of Mr Richard Wesley as the Shire Museum Advisor.

Mr Wesley is engaged to work for 20 days per annum. This work has been provided by Mr Wesley, Ms Karen Coote and Ms Hayley Johnson due to the nature of the work and the location.

The two current projects are:

1. Walgett District Historical Society – Documentation of the Barwon Lodge on Mosaic and the Historical Society Collection on Mosaic software as well as a review on the current condition and use of the Old Council Chambers.
2. Lightning Ridge Opal and Fossil Centre – Continued support with the project, particularly with a proposed site, promotion and fundraising, business plan, basics of a collection, costing and the engagement of an internationally renowned architectural team.

A copy of activity report prepared by Richard Wesley was received by Council on 5 December 2007 and is attached to this report. A letter of support received from Walgett District Historical Society is also attached.

Council has provided \$16,500 for the engagement of a Museum Advisor in its Management Plan 2007/2008 – 2011/2012. A grant from MSPA of \$10,500 has also been provided for.

## ***Museum Planning Services Funding***

Walgett District Historical Society has greatly benefited from the visits of Mr Richard Wesley and Ms Karen Coote, of Museum Planning Services and at this stage, the development of the museum is at a critical point. On-going support for their continued assistance will mean the momentum will carry forward to the betterment of the museum, training of its members and recognition of Walgett district.

We have developed a good productive working relationship with Karen and Richard and regardless of whether funding can be obtained from the NSW Government for the Museums Advisory Program, we would like to see a Council commitment provided to the program to allow, if not present level, then a slightly reduced scale. ## BACKGROUND

Museum Planning Services Australia (MPSA) has been employed by the Walgett Shire Council to provide assistance to the two main museum organizations in the Shire. This exercise has been funded through an agreement between the Shire and Museums and Galleries NSW (formerly Museums and Galleries NSW).

Under this arrangement 20 days of employment for one consultant plus travel costs are provided to MPSA to undertake its work over 12 months.

In practice the service has consisted of two, 5 day visits to the Shire plus phone support and attendance at meetings in Sydney as required per year. Support has been provided by two MPSA staff, rather than one due to the nature of the work involved and the location of the Shire. Individuals involved have been Richard Wesley, Hayley Johnson and Karen Coote.

## ISSUES

The principle issues that needed to be taken into consideration by MPSA in undertaking its contracted obligations were;

- The isolation of Walgett Shire
- A limited opportunity for civic engagement due to the absence of an elected council and senior staff turn over
- The physical separation of Lightning Ridge and Walgett Shire and the limited population base in each centre.
- The speculative, capital works basis of the Lightning Ridge Opal and Fossil Centre concept

These factors have required MPSA to work in a different way to other similar Museum Advisor Programs elsewhere in NSW to ensure the work carried out is effective and appropriate.

## WALGETT AND DISTRICT HISTORICAL SOCIETY

The Walgett and District Historical Society represents a long standing and very important community resource which is worthy of support from all levels of government, most particularly at the local level.

Over the last two decades it has built up very strong photographic archives, a good collection of documents including many council records and some 1000 artefacts. This material represents the communal memory of the town and is an invaluable resource for anyone tracking the changing historical fortunes of the district and its people.

An average of three volunteer days per week are provided to the Society by members of the executive, enabling a range of projects to be completed, from serving the public to answering numerous historical enquiries.

Through the Museum Advisors Program MPSA has been able to achieve a number of important outcomes over the last three years. They include:

- Documentation of the Barwon Lodge on Mosaic.

Through the generosity of Council the lodge has been transferred to the community. MPSA has completed basic documentation of the collection to allow a fuller interpretation of the site for members of the traveling public and organized parties. A recent visit by Sydney based lodge members to the Walgett Museum demonstrated the potential of the site for local tourism if effectively promoted.

- Documentation of the Historical Society Collection on Mosaic

With the encouragement of MPSA the Society purchased a laptop, scanner / printer and Mosaic software. This has been an absolutely critical development as it has allowed the society to keep pace with changes in museum practice. In a similar vein the Society has agreed to install wireless broadband as a means of improving communication with government agencies, historical researchers and the public.

Computer documentation of the collection has involved placing perhaps two thirds of the museum collection on the Society collection on the laptop, with each item being photographed, listed and tagged where appropriate. In the process of this work being completed, key Society members have become familiar with computer based collection documentation to the point where additional historical information can be added to each listing by them. In addition to artifacts, photographs have also been scanned into the system.

- Review of the building

The Society headquarters (formerly the Shire Council) is the finest public building in Walgett. The current of the building is ideal, providing public access and a home for the town's collection of historic artifacts and records. The rental of a front room provides a steady income for the Society, allowing it to invest in materials and services required to carry out its work.

A concern expressed by the Society, endorsed by MPSA is the on going maintenance of the building.

- There is currently water penetration in the front room and a number of the gutters are in need of repair.
- There is evidence of internal foundation failure (foyer door) however it appears to be stable at the current time.
- Overall the building is a little shabby and a 5 – 7 year painting program should be initiated to ensure the asset is protected.
- It is suggested that steps be taken to improve the under floor ventilation of the building

*The Society is willing to take responsibility for organizing repairs on the basis that they are reimbursed by Council.*

As explored in previous reports MPSA believes that the Museum could attract State or Federal funding for the construction of an extension to the rear of the property (a plan has been supplied to Council) to maximize the appeal of the complex to the public.

The proposed extension could be used for a variety of purpose including

- Additional display space in the form of a photographic / art gallery
- Craft sales outlet or
- A low key cafe.
- Storage

The model for such a development is Café 2484 at Gularganbone which operates as an important community cultural centre.

## FUTURE PROJECTS

It is recommended the Museum Advisors Program in 2008 should concentrate on a number of key projects that include.

- Current measures designed to encourage the society to continue its work, specifically a six monthly workshop and discussion program centered on the collection.

- A Collection Statement of Significance should be prepared to facilitate future Commonwealth and State Government funding opportunities. This would be part of a wider program designed to promote awareness of the collection.
- A detailed Preservation Survey needs to be undertaken to guide the future protection of artifacts at risk including the highly unusual Wolseley Bore Drain Digger.
- Development and implementation of a digital access strategy to the collection, specifically through a new website.

## RECOMENDATIONS

1. *That Council agree that the Society in the 2007 – 8 financial year organize for a roof inspection and gutter repair up to a total cost of \$1500, with Council reimbursing the Society, in July 2008.*
2. *That Council makes provision in the 2008/ 9 budget for \$2000 to be set aside for urgent painting and associated repairs, the work to be carried out by local contractors under the guidance of the Historical Society.*
3. *That Council and the Society form a joint committee to explore opportunities for the construction of a rear extension to the property as a means of expanding community use of the facility as outlined in the plan prepared by the Museum and Heritage Advisors in 2007.*
4. *That Council negotiate with Museums and Galleries NSW to continue the Walgett Shire Museum Service in the 2008 calendar year*

## LIGHTNING RIDGE OPAL AND FOSSIL CENTRE

### OVERVIEW

This project has reached a key stage in its development and it is appropriate that a process of review be initiated as part of an overall planning strategy. To date the Association has been able to achieve a number of key outcomes following the allocation of Council funds. These include:

1. Confirmation of the proposed site and completion of negotiation with relevant government agencies to allow building works to be undertaken.
2. Consolidation and expansion of the association membership base and associated income. Effective promotion of the project within the membership base and associated supporters
3. Securing the active support of an internationally renowned architectural team (Murcutt and Leeuwin) and the subsequent preparation of a design concept on a largely pro bono basis.

4. Securing funding for and over seeing the completion of a business plan which articulates how the facility would operate.
5. Developing the basics of a collection and more importantly maintaining strong links with potential donors.
6. Securing of indicative costings for the project on a largely pro bono basis.

This preliminary work has largely been completed to a high standard and reflects an intense commitment by a sizable number of people and should be acknowledged. The project concept is exciting and would have an enormous long term impact on the Shire Tourist infra structure if it comes to fruition.

### CURRENT ISSUES

The Association is currently in the throes of receiving details on the likely order of cost for developing the facility. This process involves further refinement of the design process and holding discussions with a variety of building contractors and service suppliers.

While finalization of this process is important, the most critical “success factor” is the Commonwealth Government agreeing to become a major financial partner in the project. Without this occurring it is less likely the State Government, the private sector and high wealth individuals will also come on board the project.

It is also clear from the preliminary planning process that the project will take in the order of five years to complete.

### RECOMMENDATIONS

For the project to keep moving forward it is important that a number of key decisions are taken jointly by the Association and Council in the very near future. These are;

1. *That following finalization of preliminary costings the proposal be presented personally to key individuals for comment as a means of testing the appeal of the project and obtaining feedback that can be used to refine the proposal. A key individual would be the Administrator. A suggested date is February 2008*
2. *That a fundraising campaign be agreed to by the Association and Council, commencing by June 2008 and encompassing government, the private sector, high wealth individuals and the local community. It is envisaged this plan would involve the retention of a specialist to co ordinate the campaign.*

**Summary:**

This report recommends that Council agree to operate vacation care in Walgett from July 2008.

**Comments (including issues and background):**

A request was received from Walgett Aboriginal Medical Service Cooperative Limited (WAMS) to take over the provision of Vacation Care in Walgett. Vacation care is presently operated by WAMS.

Council presently receives funding for the provision of Vacation care in Lightning Ridge, Collarenebri and Grawin estimated at \$4,940 for each program. In 2007, a total of \$14,362 was received from Department of Community Services to operate the three (3) programs.

WAMS have recently requested that Council take over the operation of the program operated in Walgett. A copy of an audited financial acquittal has been received from WAMS for the year ended 30<sup>th</sup> June 2007. The report shows that grant funding of \$13,804 was received and that the service operated within the funding.

Due to Council already operating three of the four programs within the Shire it would be considered logical for all programs to be operated collectively.

**Summary**

This report includes a summary of activities for the past three month's for the Council's community service sector.

**Comments**

**Libraries**

Northern Regional Library staff has provided monthly book and resource exchanges for the Walgett and Lightning Ridge libraries, with the exception of the November exchange which did not occur due to staffing issues at Northern Regional Library. Story Time and Christmas parties are planned with the exchange due in December. The inter library IT system from NRL has been off line for extended periods which has been frustrating for staff.

The introduction of Best Sellers has proved to be very popular with patrons.

The statistics for Lightning Ridge Library have remained constant over the past three months. Two new computers and one new printer have been installed by NRL.

The signage and revised opening hours in Walgett have increased interest in this library. This is evident by an increase in the numbers of patrons visiting the library as shown in the statistics. The number of visitors, who are passing through Walgett, has also increased with visitors commenting that they called in because of the signage. One new computer has been installed by NRL in Walgett library.

Group visits have included the Walgett Playgroup and Koolyangara Preschool. Bulk borrowing continues with Coolibah Kids Long Day Care Centre.

The CWA Book Club continues to meet in the Walgett Library with regular numbers attending every 4<sup>th</sup> Thursday.

Book Exchanges have occurred with the deposit stations in Burren Junction and Carinda.

## **Youth**

### **Youth centres.**

Attendance numbers at the Youth Centres in Collarenebri, Lightning Ridge and Walgett have increased and recent programs have proved popular with the young people. Youth centre staff have attended First Aid training and Code of Conduct training. All Youth Centre Staff and Youth Development Officer are studying Certificate 3 Community Services with Disabilities and Youth components.

## **Vacation Care**

Vacation Care programs at Collarenebri, Grawin and Lightning Ridge were attended by record numbers of children.

The Walgett Vacation Care Program is currently conducted by Goonimoo Childrens Services and is conducted at the Walgett Youth Centre. The funding received from the Department of Community Services for the program is auspiced by the Walgett Aboriginal Medical Centre. Goonimoo has recently approached Council about taking over the auspicing and management for the Walgett Vacation Care program. If this is to occur Walgett Shire Youth Services would then manage all the Vacation Care Services in the Walgett Shire.

## **Holiday Programs**

Youth Centre holiday programs and activities included a Korean Dance Group whose activities with the children included traditional dance in costume, drumming and Korean food, Storm Co, who also brought the Pinnacle of Challenge, discos, and healthy eating and lifestyle activities. The new 'Feel Good Friday' program where children plan their own activities for the last day of the week proved very popular and will be continues over the next holiday period. Discos are again proving very popular with the young people across the Shire.

Numerous organisations offered input during the October Vacation Care period with positive outcomes evident for the pooling of resources.

## **Murals**

The murals on the front of the Council Chambers were designed and painted by artists Karin Thurston and Kevin Fernando with children from Lightning Ridge and Walgett youth centres also involved. Health Eating and Healthy Lifestyle murals have also been completed on the IGA building in Walgett and the Lightning Ridge Youth Centre Ella Nagy Hall. These murals were designed by Karen Thurston and were also painted by children from the youth centres. In Walgett, teachers from the three schools brought students to the site so that they also could participate. These programs were well received by the children and have allowed children with artistic talent to be identified. A mural depicting Healthy Lifestyles has also been completed at the Grawin Opal fields on the shipping container at the Club in the Scrub. This mural was painted by the children from the Grawin Vacation Care Centre.

**Upgrade of Walgett Youth Centre Hall.**

Renovations, funded by a Regional Partnerships Grant and the Premier's Department, at the Walgett Youth Centre have been completed within the allocated timeframe. The venue is now being used by external youth organisations such as McKillop Rural Service's Reconnect Program, Blue Reelers, PCYC and Goonimoo Childrens Services Vacation Care Program.

The amenities block, also funded by the above grants and to be located adjacent to the Walgett Sporting Club, is yet to be completed.

**Cricket Camp**

A very successful Cricket Camp with 30 Indigenous youths participating was staged during the October School Holiday break. Ten youths, from the communities of Walgett, Lightning Ridge and Collarenebri, were transported to the camp daily to engage in cricket skills and drills under the guidance of the Mr. Andrew Gordon, NSW Cricket Indigenous Development Officer, Council's Youth Development Officer, youth workers and local coaches. The camp was a great success and we look forward to similar camps in the future.

**Children's Week 2007**

Walgett Shire Youth Development were successful in receiving funding from DOCS to stage events to celebrate and recognise Children's Week.

Discos were staged in the communities of Lightning Ridge with 131 young people participating and Collarenebri with 76 young people in attendance, which were excellent numbers engaging in the celebrations.

A free afternoon of entertainment was staged at the Walgett Memorial Pool in which 100 young people attended in recognition of their community's celebrations for Children's Week 2007.

**PCYC**

Youth Services staff continue to assist with PCYC activities at each fortnightly deployment. A co-ordinator has now been employed by PCYC to oversee the organisation each fortnight.

**"Care & Share, It's Only Fair" 2008 Calendar Project**

This program is aimed at reducing domestic violence and promoting happy families and is supported by the Barwon Cottage Refuge located in Walgett.

The program has been completed and we are waiting on the arrival of the calendars from the printers. Both Walgett and Collarenebri youth centre children took part in the program this year and all involved are waiting in anticipation for the final product. These will be distributed in the Walgett and Collarenebri communities

**Family Day Care**

Family Day Care continues to operate with limited carers despite constant recruiting activities. The implications of costs involved in starting up and complying with the Childrens' Services Regulations appears to be inhibiting the recruitment of new carers. The co-ordinator reports constant enquiries from parents wanting regular child care in the three towns in the Shire. Unfortunately, the Minister for Community Services has not replied in a positive manner to our request to allow the Family Day Care Cottage to be used as a Family Day facility. It is important that child care services are not closed down in rural and remote Shires such as these as it is very difficult to recruit suitably qualified staff to manage them should they wish to re-open in the future. Seven rural Long Day Care facilities, including those in Wee Waa and Coonabarabran have recently closed and this will have huge impacts on families needing childcare in these areas.

**Summary:**

This report recommends that Walgett Shire Council place a draft liquid trade waste Policy on public exhibition. The policy deals with the discharge of liquid trade waste from commercial premises into Council operated sewer and effluent systems.

**Comments (including issues and background):**

Local Water Utilities (LWU's), such as Walgett Shire Council, are responsible for the provision of water supply and reticulated sewerage services in NSW country towns.

Pollution and damage to the environment resulting from poor liquid trade waste management practices have resulted in successive governments creating a number of statutes aimed at greater protection of the environment, health and safety.

The statutes have provided LRU's with a range of tools for better management and pricing of liquid trade waste, including planning controls, approvals, levying of appropriate sewerage and trade waste fees and charges, licences, notices, orders, enforcement and prosecution controls. Statutes of particular relevance include:

- Environmental Planning and Assessment Act 1979;
- Protection of the Environment (Operations) Act 1997;
- Local Government Act 1993;
- Occupational Health and Safety Act 2000;
- Public Health Act 1991;
- Environmentally Hazardous Chemicals Act 1985;
- Dangerous Goods Act 1975;
- Radiation Control Act 1990; and
- Water Management Act 2000.

By mid 2009 Council is required to comply with the requirements of the Liquid Trade waste guidelines prepared by the department of Water and Energy (DWE).

Council's Health and Building Surveyor has attended mandatory training regarding the guidelines. This training included the preparation of a Council policy for the Discharge of Liquid Trade Waste which is based on a model policy prepared by DWE.

This policy been endorsed by the Department of Water and Energy in a letter dated 21<sup>st</sup> November 2007.

**Summary:**

Walgett Shire Council has lodged a Development Application to subdivide land at Lightning Ridge for the purpose of future urban expansion. It is recommended that the application be approved subject to appropriate development consent conditions.

**Background:**





Figure 1 – Lot proposed to be subdivided (shaded).

Development Application 2007051 has been lodged by Walgett Shire Council to subdivide Lot 2 DP 1103508 which is Crown Land held under Permissive Occupancy 1985/19 by Council. The land is located south of Lightning Ridge, as shown in Figure 1.

The Development Application proposes:

1. Subdivision of Lot 2 DP 1103508 into 2 lots, one of about 25.15 hectares and the other of about 449.3 hectares (as shown in Figure 2).
2. It is proposed that the 25.15 hectare lot will subsequently be used for expansion of the residential area of Lightning Ridge.

Within the 25 hectare area there are 7 mining camps which are predominantly located on residential Mineral Claims or Western Lands Leases for residential purposes. There are no Mineral Claims solely being used for opal mining. It also appears that none of the "residential" Mineral Claims are the subject of significant regular mining activity. There is evidence that moderate intensity opal mining has taken place some years ago on up to 1.5 hectares of the area.

Council made a resolution on 15 December 2005 to:

*"Designate the policy reserve area between the Three Mile Road, Fantasia St, Lapkalle St and the Lightning Ridge Aerodrome (part Lot 1794 DP767406) as its preferred location for urban expansion of Lightning Ridge, both for residential and industrial uses".*

The Walgett Shire Growth Management Study and Draft Strategy was placed on public exhibition from 30 July 2007 to 30 September 2007. Map 8.14 (on page 154) of that document also identifies the 25 Ha area as being proposed for residential land use. The site was identified as the most suitable for urban expansion because the area is least affected by constraints (such as opal mining and flood prone land) that surround the Lightning Ridge area. It is expected that Council will take steps to apply a residential zone to the land via a Local Environmental Plan in the near future.

**Figure 2– Lots proposed to be created (shaded, with urban expansion area also cross hatched).**




Figure 3– Detail of urban expansion area (from surveyors plan).

**79C (1)(b) Likely impacts of the development, including environmental impacts on both the natural and built environments, and social and economic impacts in the locality.**

Current land uses on surrounding lots are residential to the north and east, “residential” Mineral Claims and Mineral Claims to the west and south as well as the Lightning Ridge Aerodrome to the south.

The proposed subdivision is for the purpose of providing land for future urban expansion.

While the area is identified as the most suitable for urban expansion, it will have the effect of permanently stopping opal prospecting and mining. The magnitude and extent of this inhibition cannot be determined given it is effectively impossible to define a “resource” of opal mineralisation. Nevertheless it can be said that, historically, there has been comparatively minimal opal mining activity in the area (as demonstrated by minimal evidence of mullock dumps and limited numbers of back filled open mine shafts).

Some potential social and economic benefits include:

- Increase in choice and availability of land for residential purposes.
- Increased land supply has potential to temper land prices, thus improving affordability.
- Potential for positive local economic outcomes derived from building activity, new businesses and secondary affects from development activities.

Social and economic costs include:

- Owners of existing residential Mineral Claims may be disadvantaged by curtailment or limitation of their existing uses, requirements to upgrade to Council services or loss of privacy when development takes place.
- Loss of future opal mining opportunities in the area.

The overall benefit to the Lightning Ridge community by way of increasing urban residential land supply, is considered to be for the community greater good.

The natural environment in the area has been extensively disturbed by grazing, mining, vehicle traffic, erosion and timber removal. No significant critical habitats or threatened species populations have been identified in the proposed subdivision area.

No change to existing land use proposed at this stage.

Unlikely to be significant adverse impacts on the natural and built environments.

**79C (1)(c) Suitability of the site for the development.**

The Walgett Shire Growth Management Study and Draft Strategy nominated the site as the most suitable for urban expansion because the area is least affected by constraints such as opal mining and flood prone land. The area is also adjacent to existing Council water and sewer mains services as well as other infrastructure services.

**79C (1)(d) Submissions made in accordance with the Act or the Regulation.**

Not applicable. Under the Environmental Planning and Assessment Act 1979 the proposal is local development with no opportunity for submissions under the act or Regulation (as opposed to designated or advertised development).

One written submission was received from a notified person residing adjacent to the area. The submission expresses concern over possible complaints from noise and smoke emitted from their generator if properties are built close to their boundary. However, the Protection of the Environment Act 1997 provides that Council can issue a noise control notice. In general terms persons have no entitlement to emit noise above background levels beyond the boundary of their property.

Overall the proposed subdivision site appears to be the most suitable area for urban expansion.

In this context the proposed subdivision appears to be in the public interest.

The following matters must also be considered by Council in accordance with the respective clauses of the Environmental Planning and Assessment Regulation 2000 when making a decision on any Development Application.

**Summary:**

Walgett Shire Council placed the Walgett Shire Growth Management Study and Draft Strategy on public exhibition from 30 July 2007 through to 30 September 2007. This report recommends that Council note the submissions received, adopt the Walgett Shire Growth Management Study and Draft Strategy document with certain amendments and commence the development of a Local Environmental Plan in accordance with the recommendations made in the document.

**Comments (including issues and background):**

The Walgett Shire Growth Management Study and Draft Strategy was placed on public exhibition from 30 July 2007 through to 30 September 2007. Walgett Shire Council received twenty four submissions on the document.

Ian Sinclair, of Edge Land Planning, was the planning consultant that prepared the document on behalf of Council. Copies of all submissions received were forwarded to him, as well as the regional office of the Department of Planning in Dubbo. An "Analysis of Submissions" document was prepared by Ian Sinclair in November 2007 which summarises the issues raised and proposes changes to the recommendations contained in the Walgett Shire Growth Management Study and Draft Strategy.

- Walgett Shire Growth Management Study and Draft Strategy prepared by Edge Land Planning, dated July 2007.
- Standard Instrument (Local Environmental Plans) Order 2006.

**Financial Implications:**

Fees associated with consultancy services provided by Edge Land Planning are being met from the existing budget for Local Environmental Plan development.

**Recommendations:**

**That Council resolve to:**

- 1. Adopt and endorse the Walgett Shire Growth Management Study and Draft Strategy document, with the amendments proposed by Edge Land Planning in a document titled “Analysis of Submissions” which was prepared in November 2007.**
- 2. Forward the Walgett Shire Council Growth Management Study and Draft Strategy document to the Director General of the Department of Planning for formal endorsement.**
- 3. Prepare a Local Environmental Plan for the whole of the Walgett Shire Local Government Area in accordance with:  
(a) The Standard Instrument (Local Environmental Plans) Order 2006; and  
(b) The recommendations contained in the Walgett Shire Growth Management Study and Draft Strategy document, as prepared by Edge Land Planning.**
- 4. In accordance with Section 54 of the Environmental Planning and Assessment Act 1979, notify the Director General of the Department of Planning that Walgett Shire Council has resolved to prepare a Local Environmental Plan.**

## **Analysis of Submissions**

Ian Sinclair, Edge Land Planning

There are a number of matters raised in the submissions that have responses that are considered to be general in nature. They cover the following:

- Development on the Preserved Opal Fields
  - Residential uses
  - Low impact tourist uses
  - Conversion of Western Lands Leases to freehold
- Proposed tourist zone at Lightning Ridge

Each of these will be discussed separately.

### **Development on the Preserved Opal Fields**

The draft Strategy states that mining on the preserved opal fields should be the dominant use. Mining for opals is noisy and dusty and is not really appropriate next to housing and some tourist developments (such as cafes and restaurants) as this causes land use conflict. The pollution laws generally tend to be biased towards the residential use, not mining. If complaints are received, they must be investigated and orders can be imposed on mining operations to make them comply with noise and dust limits. This invariably leads to the mine being closed as it is not possible to meet the residential amenity expected. For this reason, the planning principle is to restrict new residential or similar uses from locating in the mining area (in this case the Preserved Opal Fields). It is not anticipated that this restriction of new uses will lead to the demise of the opal fields as the existing dwellings can be bought and sold – especially if they are converted to Western Lands Leases. Therefore it is not considered that the Strategy be amended.

It is acknowledged that tourism uses are a significant part of the Lightning Ridge economy. For this reason, it is considered that low impact tourism uses such as bed and breakfast accommodation in an existing dwelling, or opal related tourist uses like the proposed Australian Opal Centre, are appropriate for the preserved opal fields. However large tourism uses such as motels, restaurants and cafes are not considered appropriate because of the potential to conflict with the opal mining as well as effluent disposal issues. Therefore, it is recommended that the strategy be amended to allow low impact tourist uses to be permitted on the preserved opal fields.

The issue of conversion of Western Lands Leases to freehold primarily raises concerns in association with residential uses, not tourism related uses. It is considered that granting freehold title to a Western Lands Lease for residential purposes in the preserved opal fields will lead to an inappropriate form of subdivision and encourage the area to become mostly residential and not the mixture of uses as it is at present. However, if there is an existing business that has development consent and a Western Lands Lease for business purposes, there is no objection to it being converted to freehold. This is not a matter that can be addressed via a Local Environmental Plan, but it should be addressed via Council policy. This needs to be clarified in the Strategy.

### **Proposed Tourist Zone at Lightning Ridge**

A number of submissions raised the issue of providing for future tourist large scale accommodation in Lightning Ridge. To ensure that this is developed in a sustainable

manner, it should have good road access and be served by reticulated water and sewerage. It should also not impede future mining areas.

An assessment has been made of the land adjoining the Lightning Ridge urban area and it is recommended that the land in Pandora street from the edge of the residential zone to the Bore Baths on both sides of the road be rezoned to a tourist zone. The strategy should be amended accordingly. It is noted that the Council has previously given consent for caravan parks in this area but they have not yet commenced operation.

**Summary:**

This report recommends that Council seeks a financial commitment from the State Government which can be used in an application for funds under the 2008/09 Remote Aerodrome Safety Programme for upgrading perimeter fencing at Lightning Ridge Aerodrome.

**Comments (including issues and background):**

Earlier this year a report was presented to Council suggesting that an application be submitted for funding under the Remote Aerodrome Safety Programme to provide for upgrading fencing at Walgett, Lightning Ridge and Collarenebri Aerodromes to combat the kangaroo threat to flights at night. This followed concerns from the Royal Flying Doctor Service that they would suspend evening flights, except in life threatening cases, because of the kangaroo threat to their aircraft. An application was never lodged, principally on account of an absence of State Government financial support.

Correspondence has been received this month from the Department of Transport and Regional Services encouraging Council to apply in the 2008/09 funding round of this programme. It is envisaged that applications will be invited in the first quarter of 2008. However, without a financial commitment from the State Government, to at least match any funding contributed by Council, the cost of any project would be far too great for Council.

It is suggested that an approach be made at this time to the State Government, seeking a commitment to financially support an application from Council, in the event that it is successful. As indicated above, without this commitment, it is considered an application would be futile.

Even with the financial support of the State Government, the cost to Council to upgrade fencing at all three aerodromes would be beyond Council's financial capacity at the one time. Discussions with the Royal Flying Doctor Service suggest that the kangaroo threat is worst at Lightning Ridge, accordingly it is believed that it be the only site for which a funding application be considered for 2008/09.


I refer to your letter of 20 August 2007 to the Hon Reba Meagher MP, NSW Minister for Health, concerning funding for animal proof fencing around the Walgett, Collarenebri and Lightning Ridge aerodromes. Your letter has been forwarded to the Hon Mark Vaile MP, the Deputy Prime Minister and Minister for Transport and Regional Services. The Deputy Prime Minister has asked me to reply on his behalf as the Government is in caretaker mode. I regret the delay in replying.

The Remote Aerodrome Safety Programme (RASP) is a national programme aimed at assisting in the upgrade of airstrips in remote and isolated areas to facilitate the provision of non-commercial, essential air services.

Applications for Australian Government funding in 2007-08 under RASP have now closed, with the second round of applications expected to open in the new year for funding in 2008-09. I encourage the Shire of Walgett to submit an application for funding under the Programme at that time. The expectation is that the Australian Government will provide a matching contribution toward the cost of each approved project, with the balance being met by the applicant, either solely, or through an agreed funding arrangement with the aerodrome owners/operators and/or State and Local Government.

Should an application be received it will be assessed against the eligibility criteria outlined in the guidelines and against other projects located in remote Australian communities. The total funding available under RASP for the financial year 2008-09 is for a total of \$5 million nationwide.

**Summary:**

This report has been presented to Council to seek formal Council acceptance of an arrangement whereby Council's apprentice plant mechanic and a privately employed apprentice travel together and share accommodation in Dubbo during block release training periods.

**Comments (including issues and background):**

Council's Apprentice Mechanic travels to Dubbo several times a year for block release training. Council has been in the practice of supplying a vehicle for him to travel to and from Dubbo, as well as meeting his accommodation and meal expenses whilst away from Walgett. This is consistent with the support afforded to other employees undertaking off the job training relevant to their position with Council.

A second apprentice mechanic, employed by a private company in Walgett, has been travelling with Council's apprentice and sharing the accommodation which Council provides. The second apprentice meets the costs above which Council would pay if its apprentice travelled alone. This is not an equal sharing of costs, with Council meeting the majority of expense.

Contact was made with the employer of the second apprentice, seeking an arrangement where costs would be shared equally. The employer responded that they did not, and would not, meet the training costs of their apprentice, these costs being the responsibility of the individual. Accordingly, if Council elected not to allow the current situation to continue, there would be no saving to Council but considerable additional expense for the apprentice employed by the private company.

The two apprentices travelling and staying together allows them to share ideas and study together, with a benefit to both persons. For this reason alone, a continuation of the present arrangement, whereby Council is assisting this other apprentice, is supported.

**Summary:**

This report details a recommended programme for establishing a draft Asset Management Plan for solid waste services in Walgett Shire.

**Comments (including issues and background):**

This report has been written in response to a resolution passed at Council's October 2007 meeting, requiring the presentation of a report to this meeting detailing a programme for completing a draft Asset Management Plan for solid waste services in Walgett Shire.

Reliable data, upon which to base future planning for solid waste services throughout Walgett Shire, is not in place to the extent that one could confidently use it. In any case, even if it were available, the emergence of recycling as a means of minimising the waste stream into landfill, requires further research such that future facilities, service levels and assets are consistent with planned needs. Accordingly, the first step in producing an asset management plan for solid waste services in Walgett Shire is considered to be a community survey, professionally designed and carried out, such that the next steps can be undertaken with greater confidence than would otherwise be the case.

It is considered that a community survey can be undertaken and results evaluated such that shortcomings in current service levels can be adequately identified, with a report being presented to the February 2008 meeting of Council.

A draft asset management plan, incorporating associated financial and risk management plans, could then be prepared on the basis of accepted deficiencies in current service levels by the May 2008 meeting of Council. This would tie in well with the annual budgeting process of Council. The draft asset management plan could then be subjected to community feedback with Council in a position to adopt the plan in final form at its June 2008 meeting.

**Summary:**

This report recommends that Council considers works, to facilitate a reopening of the Walgett Bore Baths, when the budget for 2008/09 is determined. Deferral to 2008/09 is recommended owing to the fact that funds to facilitate the necessary security upgrading works cannot be found within the current budget.

**Comments (including issues and background):**

Representatives of a number of Walgett community organisations met last month with Council's Administrator to express their concern that the Walgett Bore Baths remain closed. Subsequent to this meeting, investigations have been undertaken in an effort to determine means by which the facility can be reopened without incurring the problems that caused Council to close the facility earlier this year.

The main issue confronting the facility is the perimeter fence. The current chainwire fence is relatively easily breached. The estimated cost of a more substantial fence, of similar specification as that which encloses the Walgett Primary School, is \$25,000. This includes two pedestrian gates, one leading from the street into the pool enclosure, the other from the pool enclosure into the toilet/change room. The availability of this toilet/change room, at the eastern end of the female swimming pool change facilities, is considered to make the request for a change facility, within the bore baths enclosure, unnecessary at this stage.

Other issues which should be addressed prior to any reopening of the facility include leakage of water from the pool and repair of some plumbing defects. The cost of this is in the order of \$8,000. A large tree, ringbarked by vandals has already been removed at a cost of \$1,200. This was done after an assessment by an arborist who indicated the tree could not be saved.

Council staff could open the facility in the morning and close it again towards the end of their working day. This would allow for about eight hours operation per day throughout the week (say 8am to 4pm). Control of access into the pool enclosure outside normal Council operating hours is essential, otherwise the problems of the past are certain to reoccur. An approach has been made to the Walgett District Sporting Club, to ascertain if they were in a position to assist by holding a key that could be used for after hours entry under controlled conditions. The club's Secretary/Manager indicate a high probability the Club's Board would endeavour to assist. However, the restrictions on key entry outside the unrestricted hours will need to be quite onerous, otherwise past problems with vandalism and anti-social behaviour are likely to return. It is suggested

that limited operation between the hours of 8am and 4pm (weekdays only) be implemented initially for a three month period and the success of this be evaluated before considering extended hours with the assistance of the Walgett District Sporting Club.

There are no funds in the current budget to provide for the expenditure required to reopen this facility in 2007/08. It is unlikely that provision for the reopening can be provided at the next budget review, unless a decision to defer or abandon another project is taken. The likelihood of savings being made within the overall pools operational budget to accommodate this expenditure is also very remote. Accordingly, it is suggested that works to facilitate the reopening of Walgett Bore Baths be considered in the context of the 2008/09 budget and that those community groups which met with Council last month be advised of this decision.

I refer to Walgett Shire Council's letter requesting an extension of financial assistance towards emergency water cartage to Grawin Opal Fields.

In accordance with Council's request I am pleased to provide financial assistance for water carting for Grawin Opal Fields for the period from 1 September 2007 until 30 June 2008, in accordance with the previous offers of assistance for carting.

The financial assistance will be based on the cartage of a long term average of 5 kilolitres per day to Grawin Opal Fields at a rate of \$660 per 18 kL load or \$36.67 per kilolitre up to a maximum of \$1280 per week. Council will be required to meet the first \$3.73 per kilolitre of water carted. Council will also be expected to meet the full cost of carting quantities in excess of 5 kilolitres per day as a long term average.

**Comments (including issues and background):**

Council submitted three proposals for consideration under the 2008/09 REPAIR Programme. Given the fact that a funding ceiling applies, it would be of no advantage to Council if more than one proposal was ultimately funded.

The three proposals submitted involved reconstruction and sealing on Regional Roads Nos 329 (Burren Junction-Collarenebri), 333 (Walgett-Carinda) and 457 (Collarenebri-Mungindi). Each project if funded would assist Council in meeting the local component of funding required on each of these roads to match the funding received under the Auslink Programme. The proposals were assessed as follows :

Regional Road No 329 – 22 points  
Regional Road No 333 – 26 points  
Regional Road No 457 – 18 points

On the basis of recent experience, it is quite probable that the proposal for Regional Road No 333 will be funded, however the chances for the other two proposals are remote at best. The principle reason that Regional Road No 333 achieves a greater number of points relates to an admission that, despite a sealed road to Warren being in existence, in practical terms Carinda is currently denied a convenient sealed access to a larger centre.

This report recommends a minor change to the advertised conditions of entry to Walgett and Collarenebri Swimming Pools to avoid a situation where school age children could be unfairly prevented from entry to these pools.

**Comments (including issues and background):**

At the current time, a sign at the Walgett Swimming Pool listing the conditions of entry indicates that school age children shall not be admitted during school hours (9am-3pm) except under school supervision. The intent of this is obviously to discourage truancy from school, however it does not allow for the situation where a school age child, in the company of a parent or guardian, has a justifiable reason to seek entry into the pool. An example could be a child from Queensland, travelling through Walgett on a holiday with their parents. Queensland school holidays are typically different from New South Wales, however the present sign could potentially prevent a child from otherwise legitimate entry into the pool.

If the sign was changed to read “school age children shall not be admitted during school hours (9am-3pm schooldays) except under adult supervision”, this potential conflict would be removed. The same arrangement should also apply at Collarenebri Swimming Pool. Local schools should be notified of this amendment.

**2. PREVIOUS MINUTES**

**Moved David Vant Seconded Alan Nelson that the minutes of the June 2007 meeting held in the Walgett Shire Council Administration Building be accepted as a true and accurate record of proceedings. CARRIED**

**3. BUSINESS ARISING FROM PREVIOUS MEETING**

**4. INCOMING CORRESPONDENCE**

**5. APPLICATION FOR SIGNPOSTING – KOOLYNGARRA PRESCHOOL**

A request has been received from Koolyngarra Preschool Aboriginal Corporation for a fingerboard sign at Fox Street and Cedar Street, pointing to their property in Cedar Street.

**Moved David Vant Seconded Alan Nelson that the request be denied as it lies outside the RTA's signposting guidelines. CARRIED**

**6. APPLICATION FOR PEDESTRIAN CROSSING**

A request has been received from the Lightning Ridge Community Working Party, that a marked pedestrian crossing be provided across Pandora Street, Lightning Ridge, at Gem Street. It is suggested this is necessary because of the number of children walking to the Sports Centre and Swimming Pool areas.

**Moved David Vant Seconded Alan Nelson that Council arranges for pedestrian and vehicle counts to be undertaken to ascertain if a warrant exists for the crossing. The results of these counts should be tabled at the next meeting of the Traffic Committee for consideration.**

**CARRIED**

#### **6. MOVEMENT OF FARM MACHINERY THROUGH WALGETT**

A request has been received that parking be abolished on one side of Warrena Street, Walgett, between Pitt and Namoi Streets, to facilitate the movement of farm machinery from the north of Walgett to the eastern side of Walgett. It was suggested that traffic parking on both sides of this street limited the available road space that wide machinery can travel along. Following discussion, it was agreed that these movements would be seasonal at most and, to abolish parking for the occasional movement of wide machinery would be unreasonable.

**Moved David Vant Seconded Steve Lincoln that the request to restrict parking in Warrena Street be denied and that the use of Pitt and Euroka Streets be suggested as a satisfactory alternative to move from north of Walgett to east of Walgett.**

**CARRIED**

#### **7. LIGHTNING RIDGE RODEO ASSOCIATION – SIGNAGE REQUEST**

The Lightning Ridge Rodeo Association has sought approval to erect permanent signposting on the Castlereagh Highway, both north and south of Lightning Ridge, to advertise their annual rodeo event as well as other town activities held on the Easter weekend.

**Moved David Vant Seconded Alan Nelson that the request be denied as it does not fit with guidelines for signage within the road reserve. Furthermore, that the Lightning Ridge Rodeo Association be encouraged to seek out appropriate land outside the road reserve and submit a Development Application to Council to provide a suitable outcome for them.**

#### **9. SPEEDING TRAFFIC – LIGHTNING RIDGE**

A request has been received from the Lightning Ridge Community Working Party, that speed bumps be installed in Black Prince Drive, Cardinal Road and Butterfly Avenue in an effort to slow down speeding traffic. Prior to the meeting, Council installed a traffic classifier in Black Prince Drive and Butterfly Avenue to allow the Traffic Committee to gain an appreciation of the seriousness of the problem. A classifier is currently installed in Cardinal Road, however results were not available to the meeting. The results did not indicate a serious problem with speeding traffic with less than 10% of traffic exceeding the speed limit of 50 kilometres per hour with most of this speeding traffic travelling less than 60 kph. The results for both streets were similar. All members of the Traffic Committee indicated opposition to speed bumps on public streets in this situation.

**Moved Alan Nelson Seconded David Vant that no action be taken to install speed bumps in Black Prince Drive or Butterfly Avenue and that a decision on Cardinal Road be taken when traffic classifier information is available.  
CARRIED**

#### **10. SCHOOL BUS PICK UP POINTS – LIGHTNING RIDGE**

A request has been received from the Lightning Ridge Community Working Party, that signage be erected on the approaches to school bus pick up points within the Lightning Ridge urban area. The Traffic Committee was not supportive of this as it was considered that the urban speed limit is 50 kph, which drops to 40 kph when a bus is stopped, has its flashing lights on and is picking up or setting down passengers. Further signs are considered unnecessary, particularly in an urban area.

**Moved Alan Nelson Seconded Steve Lincoln that the request to erect signs at school bus pick up points within the Lightning Ridge urban area be denied.  
CARRIED**

#### **11. PROPOSED SCHOOL/MARKED CROSSING – ARTHUR STREET**

Council was experiencing difficulty in obtaining competitive quotes for the construction of a school/marked pedestrian crossing in Arthur Street, Walgett. Community pressure to provide this facility appears to have dropped significantly to the point where it is questionable if the work should proceed.

**Moved David Vant Seconded Alan Nelson that the school/marked pedestrian crossing in Arthur Street Walgett be placed on hold for the present time and that Inspector Peter Szaak of NSW Police be informed accordingly.  
CARRIED**

#### **12. LIGHTNING RIDGE CARAVAN PARK**

A caravan park development, in Pandora Street, Lightning Ridge was approved by Council several years ago, however the development never proceeded. Subsequent to this, the proposal has been re-submitted for approval with some amendments by a new applicant. A new access point to Pandora Street is proposed, however this is unlikely to prove to be an obstacle.

**Moved David Vant Seconded Steve Lincoln that the Traffic Committee indicate general concurrence with the entrance/exit provisions for the proposed Lightning Ridge Caravan Park in Pandora Street, however, given the fact that Pandora Street at this point is a regional road, formal consultation with the Roads and Traffic Authority is required.

**Summary:**

The Manager Planning and Regulation attended a Camps On Claims Working Group meeting on Wednesday, 28 November 2007 as Walgett Shire Council's delegate. This report provides an overview of the matters discussed which were relevant to Council's core responsibilities. It is recommended that Council resolve to note those discussions.

**Background:**

The Camps On Claims Working Group meeting was held at 12.30PM on Wednesday, 28 November 2007 at the Lightning Ridge Bowling Club.

Bob Hewlett and Lyn Carney attended the meeting as advisers on behalf of Walgett Shire Council, whilst the Manager Planning and Regulation attended as Walgett Shire Council's delegate.

Items discussed which were directly relevant to Council's core responsibilities, included:

- Walgett Shire Council Land Use Study and Draft Strategy.
- Acquisition of land for urban expansion adjoining Fantasia St.
- Policy reserve area near Lightning Ridge aerodrome.

**Land Use Study and Draft Strategy:**

The Manager Planning and Regulation informed the working group that:

- Exhibition of the Walgett Shire Growth Management Study and Draft Strategy ceased on 30 September 2007.
- About twenty five submissions had been received.
- Council's consultant planner, Ian Sinclair was presently analysing the submissions with a view to determining whether any recommendations contained in the publicly exhibited document should be amended.
- A report on Ian Sinclair's analysis will be presented to a meeting of Walgett Shire Council to be held on 11 December 2007 where Council would decide whether to adopt the recommendations contained in the Walgett Shire Growth Management Study and Draft Strategy in the form they were exhibited, or in an amended form.

## SHIRE OF WALGETT – AGENDA

### **Lightning Ridge urban extension:**

The Manager Planning and Regulation informed the working group that:

- Council had approved a Development Application at a meeting held on 20 November 2007 for the subdivision of a 25 hectare area in the vicinity of Lappkalle St, Fantasia St and the 3 Mile road.
- Council was now taking action to have the subdivision registered with the Land Titles Office and acquire the 25 hectare area from the Department of Lands.

### **Policy reserve near the Lightning Ridge aerodrome:**

The Manager Planning and Regulation informed the working group that:

- At the last Lightning Ridge Mining Board meeting the Lightning Ridge Miners Association continued to push for Walgett Shire Council to agree to allow access to the whole of the residual of the policy area between area between Lappkalle/Fantasia Sts and the Lightning Ridge Aerodrome (apart from the 25 hectares currently being acquired for urban expansion). It also asked that Council consider other areas that were not available for opal mining and prospecting.
- The board had requested that Council consider and convey its position to the Department of Primary Industries.
- At a recent meeting Council resolved to allow access to:
  - Up to 25% at a time of the policy reserve area near the Lightning Ridge aerodrome.
  - Up to 50% of the freehold land near the intersection of the Bill O'Brien Way and the Castlereagh Highway.
  - Up to 50% of the statutory reserve located near the Lightning Ridge gun club.
- Council's position has been conveyed to the association, but it has not yet received a formal response.

**Summary:**

The Manager Planning and Regulation attended a Lightning Ridge Mining Board meeting on 29 November 2007 as Walgett Shire Council's delegate. This report provides a summary of the matters dealt with which were directly related to Council's core responsibilities and recommends that Council resolve to note this report.

**Background:**

The Lightning Ridge Mining Board meeting was held at 10.30AM on 29 November 2007 at the Lightning Ridge Bowling Club. The Manager Planning and Regulation, Matthew Goodwin, attended as Walgett Shire Council's delegate.

Items discussed which were directly relevant to Council's core responsibilities, included:

- Gazetted reserves/policy reserves.
- Mining SEPP.
- Trespassing on Western Lands Leases and Mineral Claims.

**Gazetted reserves/policy reserves:**

The Manager Planning and Regulation informed the Board that:

- At a recent meeting Council resolved to allow access to:
  - Up to 25% at a time of the policy reserve area near the Lightning Ridge aerodrome.
  - Up to 50% of the freehold land near the intersection of the Bill O'Brien Way and the Castlereagh Highway.
  - Up to 50% of the statutory reserve located near the Lightning Ridge gun club.
- Council's position has been conveyed to the Department of Primary Industries and the Lightning Ridge Miners Association (LRMA), but it has not yet received a formal response.

The LRMA representatives stated that a formal response would be forthcoming.

**Mining SEPP:**

The Manager Planning and Regulation informed the Board that he had been involved in ongoing discussions with Department of Primary Industries staff about the Mining SEPP. Those discussions suggested the SEPP was incomplete because it provides no indication whether development consent is, or is not, required to allow the renewal of a Mining Purposes Lease. In that context Council would be writing to the Department of Planning to seek clarification of the matter.

**Trespassing on Western Lands Leases and Mineral Claims:**

Landholder representatives sought an indication whether Walgett Shire Council would be willing to participate in the erection of signs along, or at the end of, public roads indicating unauthorised access to Western Lands Leases or mining areas was prohibited.

The Manager Planning and Regulation stated that he thought such assistance would be outside Council's core responsibilities, and hence unlikely. Nevertheless, Council would consider any formal request it received via a letter.

The Manager Planning and Regulation also advised the Board that issues raised at the previous board meeting regarding unauthorised access were being given appropriate consideration by Council's tourism staff in course of revising tourism related brochures.
